

Tutors On Demand Terms of Use for Tutors

Last updated February 3, 2022

In addition to these Terms of Use for Tutors, all tutors must accept both Tutors On Demand's General Terms of Service and Privacy Policy before being allowed to register as a tutor. Completing the registration will be construed as unequivocal acceptance of all policies and agreements required to become a member of the tutoring team of Tutors On Demand; these agreements are legally binding.

All tutors with Tutors On Demand are under the following obligations:

1. To treat all personal information of students/clients with complete confidentiality.
2. To prepare for tutoring sessions prior to the scheduled tutoring session, as much as possible, in order to optimize the student's session time.
3. To conduct all interactions with students and clients with honesty and integrity.
4. To keep all personal and professional information on Tutors On Demand up-to-date, including the scheduling calendar.
5. To attend all scheduled tutoring sessions, on time, and for the complete time scheduled.
6. If needing to cancel a tutoring session, informing the student/client with a minimum six (6) hours notice, and rescheduling if possible.
7. To confirm that any under-aged students are registered and participating with the permission of their parent, parents, or legal guardian.

Tutors On Demand

1. Only undertakes the handling and operation of the Platform with the sole purpose that Clients/Students are able to get in contact with Tutors. We do not provide tutoring services of any kind.
2. Does not act as an agent of any User, nor do we verify the suitability or investigate the extent of the knowledge of Tutors.
3. Has no obligation to make any minimum commitment of work, time, or compensation to the Tutor.
4. Is not liable for any Client/Student who does not attend at the agreed time he/she/they booked through the Schedule Calendar.
5. May terminate its tutor referral service at any time and for any reason.
6. May also deny anyone access to its tutor referral service at any time and for any reason.
7. Has a right to request a Tutor to correct information it deems inexact.
8. Has a right to validate through third parties the information and documentation provided by the Tutor, only with the purpose of confirming he/she/they has the required governmental authorizations as a teacher or the required university GPA of 3.0 or higher. If the information is false or inexact, Tutors On Demand may suspend the profile of the Tutor.

User account verification for Tutors is subject to the following guidelines:

- I. A Tutor must provide valid and legal personal and professional information. The information includes:
 - i) full legal name;
 - ii) email address;
 - iii) phone number.
- II. A Tutor who is an accredited teacher must also provide his/her/their
 - i) licence and/or professional identification number;

- ii) years of experience;
- iii) specialty subject or subjects.

III. A Tutor who is currently enrolled in post-secondary schooling must also provide proof of a consistent GPA of 3.0 or higher.

IV. A Tutor may only have one User Account; no one is allowed to create a common User Account for several tutors. Repeated profiles will be deleted.

A Tutor may only publish his/her/their own photo. It is forbidden to publish images of another person, as well as all types of graphic works (for example, logos). It is also forbidden to publish pornographic, obscene, offensive, immoral, or unprofessional photos.

The agreement between a Tutor and Tutors On Demand reflected in these Terms is in effect when the Platform is accessed (for example, to create an account) and remains in effect until one of the parties rescinds the agreement. This agreement may be rescinded at any time by the deletion of the Tutor's account. Tutors On Demand may rescind this agreement and a Tutor's account for any reason by giving notification 30 (thirty) calendar days in advance, via email or using any other contact information provided in an account. Tutors On Demand may also rescind this agreement immediately and without previous notice and cease to provide access to the Platform if any Terms, Policies, or applicable laws are breached or violated, or if it is considered that the rescission is necessary to protect Tutors On Demand, its Users, or third parties. If an account is inactive for more than two years, Tutors On Demand may cancel it without prior notice.

Tutors may upload various content (the "Content") to the Platform via their User Account (i.e., photographs of the Tutor). But it is forbidden for Tutors to upload advertising or content of third parties. Tutors On Demand does not ensure the truthfulness or reliability of all Content.

Tutors On Demand may revise and update these Terms of Use at any time and without notice to you. You are cautioned and encouraged to review the Terms of Use posted on this website periodically. Your continued use of the website will constitute a deemed acceptance of any changes.

This agreement is valid despite errors, fraud, bad faith, or any other conditions relevant to its validity.

These Terms of Use shall be governed by the laws of the Province of Saskatchewan and the Federal laws of Canada applicable therein. Any disputes shall be governed by the Courts of the Province of Saskatchewan without reference to conflict of laws principles.

By using the Tutors On Demand's website and its tutor referral service, you acknowledge that you have read these Terms of Use and agree to be bound by them.
